

**A.HPE Super Slots Program – Program Structure** Under the HPE Super Slots Program (the 'Program'), HPE End-Customers register to qualify for a free gift with the purchase of a new HPE Product under conditions set forth with the following Program terms and conditions ('Program Terms').

Unless requested to accept these Program Terms online or otherwise, Participants acknowledge and agree that participation in the Program constitutes acceptance of these Program Terms.

**D.Eligible Participants**

Only HPE End-Customers are eligible to participate in this Program.

HPE End-Customers of public sector are not eligible to participate in this Program.

Qualifying HPE End-Customers must register to participate in the Program. Registration guidance is provided under section C below.

HPE End-Customers who have successfully registered to participate in the Program are referred to herein as "Participants".

**E.Eligible Products**

HPE Storage products sold by HPE or an authorized HPE Reseller to the Participant and eligible for a Gift with Purchase are referred to herein as "HPE Products".

Please see eligible HPE Products in Appendix A of this Program Terms.

Only new HPE products are eligible to take part in the program. Demonstration products as well as remarketing or used products are excluded from the program.

The Program is not valid if the HPE Products will be resold or rented to a third party.

**F.Program Territory**

The Program is valid in Deutschland.

Active sales of the HPE Products must be made to HPE end-customers only located in

- (i) The country of the Participant or
- (ii) The Territory as per the HPE Partner Agreement if applicable.

A list of all participating countries can be found in Appendix B.

**G.Program Requirements**

With the purchase of an HPE Product with 15 cartridges within the Program period as defined in section H, the Participant can qualify for an additional free media kit with 9 cartridges.

The additional free media kit will be shipped to the address provided by the Participant within the application process. The shipment can only be made to an address within the country of registration.

Per Participant only one claim for the free media kit is accepted.

This Program is valid while supplies last.

**H.Program Period**

The Program period starts on 01.07.2025 and ends on 30.04.2026 .

All purchases of HPE Products between 01.07.2025 and 30.04.2026 are eligible to be registered in the Program.

Registrations must be submitted online, within 60 days after date of purchase.

The date of invoice provided in the application process shall be considered as the date of purchase.

**I.Application Process**

The participation in the Program consists of the following steps:
